Dear Residents and Families/Representatives,

Please accept this letter as our weekly update regarding the status of COVID-19 in our facility. Since the onset of this virus, we have had 49 residents and 47 staff members test positive for COVID-19.

We continue to work with Walgreens for onsite COVID 19 Vaccination Clinics. We have completed two of our three scheduled clinics. To date we have had 90 employees/residents complete the vaccination process. Our final clinic is scheduled for March 5, 2021.

We continue to test employees and residents in accordance with CDC guidelines which includes monitoring our weekly county positivity COVID 19 rate.

We continue to provide visitation in accordance with CDC guidelines based on new positive COVID 19 cases diagnosed in our resident and staff population. At this time, our visitation is limited to window visits. Please contact Jessica or Coco in our Activity Department at 864-227-9500 to schedule a visit. We do ask that visits be scheduled 24 hours in advance to allow for coordination with staff.

As always, we are working hard to keep everyone in our community safe and we will continue to practice the enhanced safety precautions that are known to prevent the spread of COVID-19, such as only essential personnel are allowed inside the facility and we screen them for signs and symptoms of illness prior to entering. Our residents are continually monitored and staff is using PPE as recommended by the CDC. Staff is frequently reminded and encouraged to practice social distancing and to use hand sanitizer and frequently wash their hands when they are in the facility and out in the community. We ask them not to report to work if they have symptoms of illness.

We do ask that visits be scheduled 24 hours in advance to allow for coordination with staff on duty and to allow for proper disinfecting.
